In this Release Agreement the term "On-Snow Programs and Safaris" includes skiing and snowboarding lessons, orientation or instructional sessions, guided ski and snowboard safaris, tours and clinics, competitions and events, access to the ski area and use of all facilities including lifts.

ASSUMPTION OF RISKS

I agree to assume all risks, dangers and hazards of participating in On-Snow Programs including, but not limited to: boarding, riding and disembarking ski lifts; loss of balance or control; slips, trips and falls; collision or impact with natural or man-made objects or with other persons; becoming lost or separated from one's party; failure to act safely or within one's own ability or to stay within designated areas; travel within or beyond the ski area boundaries; and negligence on the part of Ski Adventures (SAC SKI Pty Ltd) and its directors, officers, employees, ski and snowboard instructors, guides, volunteers, agents, independent contractors, subcontractors, representatives, sponsors, successors and assigns (hereinafter collectively the "Releasees"). I understand that negligence includes failure on the part of the Releasees to take reasonable steps to safeguard or protect me from the risks, dangers and hazards of participating in On-Snow Programs & Safaris.

RELEASE OF LIABILITY

I agree to waive any and all claims and to release the Releasees for any and all liability from any loss, damage, expense or injury, including death, that I may suffer as a result of participating in On-Snow Programs and Safaris, due to any cause whatsoever, including negligence, breach of contract or breach of any statutory or other duty of care, including any duty of care owed under the Occupiers Liability Act on the part of the Releasees. I understand that negligence includes failure on the part of the Releasees to take reasonable steps to safeguard or protect me from the risks, dangers and hazards of participating in On-Snow Programs & Safaris. I agree that any litigation involving the Releasees shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia. I further agree that these conditions and any rights, duties and obligations of the Releasees shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction.
